This is extra footage that is shot during the reception to interview some of the guests. They can be asked a question of your choice or they can just express their thoughts of the ceremony.

☐ Photo Montage **\$45** ☐ 2nd song (100 photos) **\$80**

You provide any images you wish in digital format or hard copy (to be scanned and returned) in order to create a basic video slideshow also set to the music of your choice.

MAXIMUM 50 photos set to 1 song. Additional song (+50 images) = \$30

Terms and Conditions:

- Due to the need to coordinate travel schedules and obtain all required equipment for your event, date(s) shall be confirmed and contract signed at least 2 months in advance.
- In order to reserve your date(s), the deposit, as described below, shall accompany the contract and be received prior to 2 months of the event date.
- Your deposit is half of the total package price including any extras requested. This is a **non-refundable** deposit for any cancellation or change in event dates. However, if an event is rescheduled and my service is still desired, your deposit will be held and applied to the new event date, pending schedule availability.
- No more than one event reschedule will be allowed under the same deposit.
- Any travel expenses (for events farther than 50 miles from Spincreation's origination point) shall be paid for in addition to the total cost of the production. These expenses may include, but are not limited to: fuel, lodging (if necessary), and meals during stay. Expenses will be added to the final cost and will be presented to you (with appropriate receipts) prior to project delivery.
- The remaining balance of your project will be due prior to the delivery date of your video (this includes travel expenses, if required). Final payment can be made at any time before actual delivery of your video.
- In the unforeseen event the footage is damaged or destroyed by uncontrollable acts, your deposit will be returned in full minus any incurred travel expenses.
- You agree not to hold Spincreation Productions liable for footage that is damaged or destroyed.
- The videographer(s) must view the location (or be present for a rehearsal) prior to the scheduled event in order to achieve best results for your special occasion.
- Please allow at least 8 weeks from the date of your event for project delivery. Time will vary depending on project size and number of productions in process at the time of your event. Please contact us to receive updates of your production.
- Your project will be archived to provide a lifetime guarantee of your special event. If in the event your copy becomes unusable, in all conditions except that of normal wear and tear, your video will be replaced at no charge. This guarantee will be contingent on the returning of the unusable product and testing of reported problem(s). All other conditions will require a purchase of an additional copy at the current listed price.
- Spincreation reserves the right to add, change, and delete items on this agreement at anytime. In the event a change affects your event you will be notified accordingly as soon as feasibly possible.

Initial I understand the above Terms and Conditions and agree to abide by statements herein. Any changes to event date or time as listed above may void this contract and payments received to date unless stated otherwise above. Upon signing this contract, you agree to work with Spincreation in any manner necessary to allow the best video production possible. Spincreation will not be held liable for any lost or damaged footage, regardless of the conditions other than negligence.
